Accident Risk on Ghatkopar-Andheri Link Road,

Demand for Action Against Illegal Parking and Installation of Speed Breakers,



Ghatkopar, Ajay Upadhyay:

Heavy traffic movement has been reported on the Ghatkopar-Andheri Link Road, particularly between C.S.D. Colony and Shreyas Signal, as well as from Shreyas Signal towards Jagruti Nagar and the road leading to Ghatkopar railway station. However, the absence of speed breakers along this stretch has resulted in vehicles speeding, posing a serious threat to pedestrians, schoolchildren, and parents attempting to cross the road.

Between Shreyas Signal and C.S.D. Colony, a large number of vehicles are being illegally parked in the middle section of the road leading towards Jagruti Nagar Metro Station. This has been causing severe traffic congestion during evening hours. Due to the parked vehicles, oncoming traffic is often not clearly visible, forcing pedestrians to risk their lives while crossing and significantly increasing the chances of accidents.

In light of the situation, citizens have strongly demanded that traffic police take immediate and strict action against illegal parking on the Ghatkopar-Andheri Link Road. Residents have urged authorities to install a speed breaker at Garden View Point while approaching Jagruti Nagar from Shreyas Signal, and another in the central stretch for vehicles traveling from Jagruti Nagar towards Shreyas.

Attempts were made to contact Traffic Police Inspector Chandrakant Koli for a response, but he could not be reached.
