दिल्ली, नवराष्ट्र न्यूज नेटवर्क. देशातील सार्वजनिक क्षेत्रातील बँका लवकरच रिझर्व्ह बँक ऑफ इंडिया (आरबीआय) कडून हवामान वित्त आणि जोखीम व्यवस्थापन नियमांमध्ये बदल करण्याची विनंती करू शकतात. सध्याच्या नियमांमध्ये ग्रीन डिपॉझिटना प्रोत्साहन देण्यासाठी आवश्यक सुविधा नाही, असे बँकांचे म्हणणे आहे. डिसेंबर २०२५ मध्ये, आरबीआयने 'कमर्शियल बँक क्लायमेट फायनान्स अँड मॅनेजमेंट ऑफ क्लायमेट चेंज रिस्क' शीर्षक असलेली मार्गदर्शक तत्वे जारी केली. या नियमांमुळे बँक बोर्डांना ग्रीन डिपॉझिट आणि क्लायमेट फायनान्स-संबंधित जोखीमांसाठी तपशीलवार धोरणे विकसित करण्याचे आदेश दिले. ग्रीन डिपॉझिट योजनेअंतर्गत ग्राहकांचा सहभाग आतापर्यंत कमी आहे, असा अहवाल बँकांनी दिला. प्रामुख्याने बँकांना किंवा ग्राहकांना कोणतेही विशिष्ट फायदे मिळत नसल्यामुळे आहे. बँकांच्या प्राथमिक मागण्या म्हणजे ग्रीन डिपॉझिटवरील रोखे राखीव प्रमाणाचा अभाव आणि क्लायमेट फायनान्स वर्गीकरणावर अधिक स्पष्टतेची आवश्यकता आहे.
